### Course Description

This course is an overview to the taxation of corporations (both “C” and “S”), partnerships, and estate and gift tax planning. It also discusses tax research techniques and professional responsibilities in tax practice.

Exam 3 is not cumulative. All exams are open notes, open book. However, this is merely to avoid unnecessary study time memorizing facts, and you should not rely on access to the book and notes as a substitute for study for the exam. If you expect that you will be able to answer questions by reliance on the notes and book, you will very likely run out of time to finish the exam. Study in the same way that you would for any exam, with the knowledge that if you forget a specific fact that you will be able to check your source materials. The two assignments will be done outside of class and the details will be announced later. The research assignment will be done the week of November 8 and there will be no class meetings on November 8 or 10.
